**RESPONDENT'S MOTION TO EXTEND DEADLINE FOR FILINGS**

**COMES NOW** Respondent, **GERALDINE CABEZUDO**, pro se, and pursuant to Rule 1.090, Fla. R. Civ. P., respectfully moves this Court to extend the deadline arbitrarily imposed on September 16, 2025, and in support states:

1. On **September 16, 2025, at 2:51 PM**, this Court sua sponte imposed a filing deadline without providing legal basis or justification.
2. On the very same day, **September 16, 2025, at 10:19 AM**, Non-Party **John Chidester** engaged in email correspondence with Petitioner's Attorney **Garth Goodman** demanding a copy of the original subpoena that was served to him on September 13, 2025. Later that evening, at **11:59 PM**, John filed his **Non-Party Motion to Quash** all three conflicting versions of the subpoena issued by Goodman.
3. It is not coincidental that Judge Helinger's arbitrary deadline was imposed on the **same day** as this email exchange and motion filing. The timing gives rise to a reasonable concern that **impermissible ex parte communication occurred between opposing counsel and the Court.**
4. Additionally, Respondent filed her **Motion to Subpoena John Chidester** at **4:56 PM** on **September 16, 2025**, which the Clerk and Court have failed to process despite her e-filing within the deadline timeline.

5. The refusal to process these filings, combined with the sudden and unexplained imposition of a deadline, materially prejudices Respondent by preventing her from presenting five critical witnesses, including John Chidester, for the October 1, 2025 hearing.
6. Florida law disfavors arbitrary deadlines and exclusion of witnesses unless prejudice or willful misconduct is shown. *Binger v. King Pest Control*, 401 So. 2d 1310 (Fla. 1981).
7. The Florida Supreme Court has emphasized that all litigants must be afforded a meaningful opportunity to be heard. *Perlow v. Berg-Perlow*, 875 So. 2d 383 (Fla. 2004).
8. The Court's failure to process timely filings, combined with the suspicious timing of its sua sponte deadline, violates Respondent's due process rights and undermines public confidence in the impartial administration of justice.

**WHEREFORE**, Respondent respectfully requests this Court:

- a. Extend the deadline for filings related to the October 1, 2025 hearing to **September 30, 2025, at 11:59 PM**;
- b. Direct the Clerk to process both the Motion to Subpoena John Chidester (filed at 4:56 PM on September 16, 2025) and the Non-Party Motion to Quash (filed at 11:59 PM on September 16, 2025); and
- c. Grant such other relief as this Court deems just and proper.

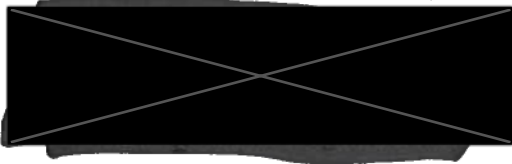

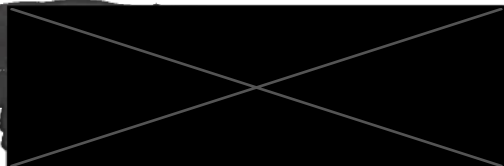
