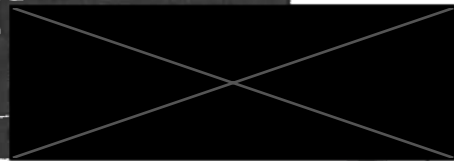



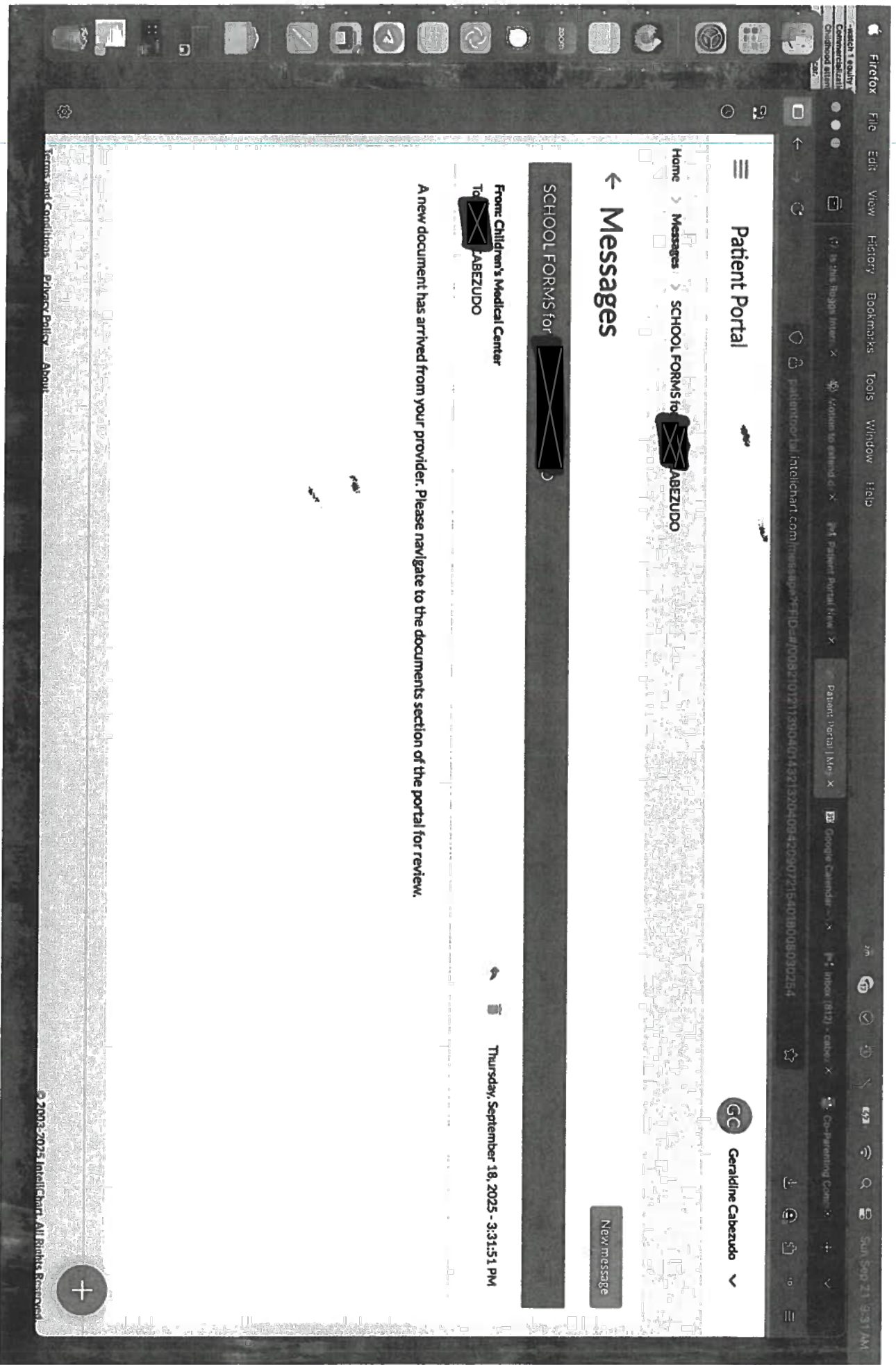

**AFFIDAVIT OF WITNESS
STATE OF FLORIDA

BEFORE ME, the undersigned authority, personally appeared GERALDINE CABEZUDO, who being duly sworn, deposes and states:

1. My name is Geraldine Cabezudo. I am the Respondent in the above-styled case.
2. On August 5, 2025, Petitioner, Andrew Cabezudo, stated via Talking Parents that he had administered vaccines to A.K.C.C. (DTAP, MMRV, Polio, Varicella). The North Pinellas Children's Medical Center (NPCMC) form dated April 29, 2025 lists only vaccinations from July 31, 2024 and none from August 2025 yet was submitted on the NPCMC patient portal as a "new" document on 9/18/25.
3. I never took the children to the doctor on April 29, 2025. They were with me on that date.
4. On September 19, 2025, I asked Petitioner for updates regarding A.K.C.C.'s health. He failed to provide me with any information.
5. I requested from Petitioner the contact information of A.K.C.C.'s teacher and to be included in Z.J.C.C.'s August 13, 2025 Pinellas County Individualized Education Plan/Individualized Family Service Plan (IEP/IFSP) transition meeting. On August 12, 2025, during Z.J.C.C.'s Marion County IEP/IFSP transition meeting, I expressly requested to be included in the August 13 meeting. Petitioner refused to include me, despite my being the only signing family member for Z.J.C.C., who communicates exclusively through sign language.


6. On August 17, 2025, during a recorded video call, both children were in a moving car with Andrew and Gloria Cabezudo. A.K.C.C. was unbelted for the entire 30 minutes, engaged in self-injurious behaviors (scratching and hitting his own face) and aggressive behaviors (kicking Petitioner). I pleaded for the car to stop to calm A.K.C.C. and to improve video fidelity, but they refused. A.K.C.C. could have opened the door into traffic. I contacted the Pinellas County Sheriff and provided the recording via the sheriff's video link he directed me to use via August 17, 2025 phone call.

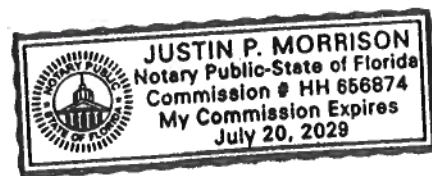
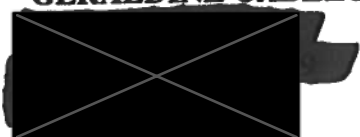

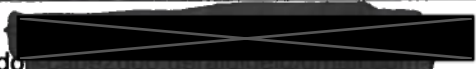
