  - Prescription records and medication logs;
  - Specialist or therapy records (including speech, occupational, physical therapy, etc.);
  - Any electronic health summaries or patient portal printouts.
- 2. All educational records** for both children since **July 1, 2025**, including but not limited to:

- School enrollment forms, progress reports, grades, and attendance records;
- Individualized Education Program (IEP), Individualized Family Service Plan (IFSP), or 504 Plans;
- Teacher notes, therapist notes, disciplinary reports, or parent communication logs;
- Evaluations, assessments, or standardized testing reports.

**3. Any and all correspondence or communications** received by Petitioner from medical providers, schools, or related institutions regarding the children since **July 1, 2025**.

**4. Any applications, registrations, or signed forms** relating to the children's medical care or schooling since **July 1, 2025**.


